Several Questions

GST – Challenges Ahead

.. but they are solvable

- Taxation is actually getting simplified with GST however room for manipulation is reduced
- Book keeping has to be fairly accurate with reconciliation needed between your purchases and supplier records in order to claim tax credit
- Taxation will be based on the bill to party, so care to be exercised while raising invoices
- It is mandatory to keep records of your suppliers and customers GSTN Id for you to claim tax credit
- Monthly submission of Invoices and purchases, so data should be available readily
- In the traditional method of operations, need to employ an accounting professional (or a team of professionals) to keep the books tidy
